Monday, October 15: <u>Reconstructing Espiritu: A</u> <u>Chumash Woman in 19th Century Calabasas</u>:

Presenter: Susan Kinkella, Professor of History at Moorpark College (American History, Native American History, and Women in American History) Professor Kinkella will discuss her research on Espiritu Leonis, a Chumash woman who lived during times of great transition and upheaval in 19th Century California. Espiritu's story illustrates the difficulties and triumphs that women experienced as they negotiated within and beyond the "appropriate" roles of race and gender. The realities of historical research in local context will also be explored.

Monday, November 19: <u>Early Warner Brothers</u> <u>Studios:</u> by E.J. Stephens and Marc Wanamaker: Presenter: E.J. Stephens, Historian and author, E.J. Stephens, will discuss the history of Warner Studios (1920's to 1950's) from the 110-acre Burbank film factory, the making of the Warner Bros. film moguls, filming the Westerns shot on location at Iverson Ranch such as the Lone Ranger (1956) and others in the Chatsworth area. Chatsworth Nature Preserve

The Chatsworth Nature Preserve, (CNP) formerly Chatsworth Reservoir, is the largest City of Los Angeles open space preserve. CNP extends over 1300 acres and is an integral part of the proposed Rim of the Valley Wildlife Corridor. It teems with wildlife, more than 200 species of birds are on the site including **Residents**: Greater Roadrunner, California Quail, sapsuckers, woodpeckers, herons and egrets; **Migratory birds**: Canada Geese, variety of ducks and shorebirds, Western Meadowlarks; **Raptors**: Ferruginous Hawk, Red-tailed Hawk, Prairie Falcon, Long-eared Owl, and many others; **Amphibians and Reptiles** include: Western spadefoot toad, slender salamander, western skink, ring-necked snake, red racer and much more; **Larger animals**: desert cottontail rabbits, gray fox, coyotes, raccoons, and occasional visits of bobcats, cougars and mule deer. The CNP habitat includes oak woodland and savanna, riparian areas, chaparral, grassland, and a once beautifully maintained ecology pond.

History of CNP: Former Los Angeles City Councilman Hal Bernson, and other community leaders, worked together to create the "Chatsworth Nature Preserve" all 1325 acres protected under City Ordinance No. 169723, 1994, limited to a Nature Preserve and accessory uses only. In recent years the CNP in LA City District 12, former councilman, Greig Smith, negotiated with the Department of Recreation and Parks (RAP) on future management. A variety of plans were considered by modifying the existing seasonal wetlands and adjacent areas, 44 acres on the southwest side of the preserve. The mitigation included an environmental easement to ensure the wetlands are protected in perpetuity. The transfer of this area from DWP to RAP is part of the proposal with all associated costs initially borne by Republic Services (formerly BFI.) Long-term plans involve transferring the 44 acres and remaining CNP acres, approximately 96, through another mitigation plan and ultimate transfer to RAP. DWP will continue to own-manage the remaining acreage, which includes the Ecology Pond.

The Ecology Pond began to dry up over the hot summer months. The newly formed Chatsworth Nature Preserve Coalition (CNP Coalition), community residents, and others began a campaign to have the Ecology Pond refilled by making phone calls and writing letters to DWP and making calls to Mitchell Englander's office, Council District 12. The pond was refilled the end of July but there is great concern about the immediate damage to the surrounding marsh, habitat for the birds, and future maintenance of both the Ecology Pond and the entire Nature Preserve.

PEARL G. TURBUSH

June 26, 1916 – June 22, 2012

With sadness we announce the passing of Pearl G. Turbush. She served as the Santa Susana Mountain Park Association (SSMPA) president from 1977 – 1979 and later as the Foundation for the Preservation of the Santa Susana Mountains (FPSSM) president from 2002 – 2010.

Pearl worked alongside the SSMPA/FPSSM Founder, Janice Hinkston, fighting to create the Santa Susana Pass State Historic Park (SSPSHP). A Daily News 2003 article titled, "Supporters of ailing historic park hire lobbyist to woo Sacramento cash" quotes Turbush. "We felt we were being cheated by Sacramento" with reference to her as an environmentalist and park champion. She was passionate, smart and fought for over forty years with local and state politicians for every inch of SSPSHP. SSMPA and FPSSM are indebted to Pearl Turbush for all her years of dedicated service to the Chatsworth and Simi Valley communities for saving and protecting our local history and beautiful park.

Services were held on June 26, 2012 The Los Angeles County Board of Supervisors, on a motion by Supervisor Michael Antonovich, adjourned its July 3, 2012 meeting in memory of Pearl Turbush. -- Carla Bollinger

UPDATE!! UPDATE!! CHATSWORTH PARK SOUTH

Tom Nachtrab, new SSMPA Board Member, reports an update to the status of the long-closed Chatsworth Park South (CPS) but there is little to celebrate. Yes, the City did complete removal of brush from the park in Mid-August, a fire prevention measure. But prospects for re-opening of any portions of the park are now more distant than ever.

Tom discovered that the Department of Toxic Substance Control (DTSC) delayed its DUE DATE for the completion of a Remedial Action Plan for Chatsworth Park South by almost a year (from July 30, 2012 to July 19, 2013.) This deferral of the plan apparently means that we cannot expect any actual clean-up work to begin before August 2013 at the earliest. The due date of the plan was revised by the DTSC and the City of Los Angeles project team in June 2012, only about a month after DTSC's update to the Chatsworth Community Coordinating Council on April 23, 2012.

Why the delay of a year? According to a DTSC spokesperson: "Some of the determining factors included funding issues, budgets, and a comprehensive evaluation of potential remediation methods and plans available for the Site."

The CPS closed on Valentine's Day, 2008 because of Roy Rogers' skeet ranch that operated over 50 years ago. No one has ever reported illness at this location from the clay pigeon targets and lead shotgun pellets in the ground. Chatsworth Park South has been closed for 1,659 days, as of September 1, 2012 - Tom Nachtrab
