SSMPA Supports Moratorium on Re-Opening of Aliso Canyon Gas Reservoir

California **Senate Bill 57** (Stern, Hertzberg, Wilk) is working its way through the legislative process in Sacramento. It calls for extension of the moratorium on the use of the Aliso Canyon gas storage facility until a full root-cause analysis of the 2015-16 leak is done and released to the public.

The Board of Directors of the Santa Susana Mountain Park Association (SSMPA) supports the passage of SB 57.

The U.S. Department of Energy released in January 2017 its Draft Environmental Impact Statement for Cleanup at the Santa Susana Field Lab.

SSMPA appreciates that the U.S, Department of Energy accepted its responsibility to define the characteristics (physical, economic, environmental, etc.) of a full range of possible cleanup alternatives.

### Hidden Creeks Development next to Aliso Canyon

Update from the Office of the 5th District from Los Angeles County Supervisor Kathryn Barger on the Hidden Creeks Development Project

<u>Supervisor Barger</u> continues to direct staff to further the discussion on converting the <u>proposed Hidden Creeks Development Project</u> into dedicated open space.

She remains concerned about the viability of this project, as the property lies immediately adjacent to the **Aliso Canyon Gas Storage Facility**. Supervisor Barger believes that this is not a suitable place for a residential development. While the project is still being processed through the City of Los Angeles, the land is County-unincorporated, and the project must receive approvals from the Los Angeles County Board of Supervisors.







Most importantly, the Los Angeles County Local Agency Formation Commission (LAFCO) must also approve the project. Supervisor Barger will continue to be proactive in the process, and will work with all stakeholders to do what is in the best interest of all Chatsworth and Porter Ranch residents.

### We're Proud of "The Bird Lady"



SSMPA Board Member Wendi Gladstone, also known as "The Bird Lady" in Calabasas, was honored by the Calabasas Environmental Commission at their February 7th meeting. She received the Commission's 2016 Carl Gibbs Environmental Excellence Award.

Wendi was recognized for her commitment to protect the environment through environmental science programs for schools, surveying the Calabasas Lake wildlife, and educating the public on the protection of wildlife habitat.

In addition to collecting data the past five years, she shares her bird knowledge

with residents, makes note of potential hazards - like trash, poison bait boxes or standing water - that could harm birds or other wildlife, and alerts the Lake's homeowners association board and lake management of these issues.

### **Deerlake Ranch Development Update**

Deerlake Ranch, a 314-home <u>residential development</u> north of the 118 between De Soto and Topanga Canyon Blvd. that is currently in the grading stages, took a big step forward March 23 and 24 when Foremost Communities, developer for the project, brought in a 250-foot crane to transport giant steel beams across Devil Canyon. Five truckloads of steel girders, the longest precast girders ever made in California, travelled all the way from Stockton and were carried up De Soto to Devonshire and then over to Canoga. The 170-foot long, 12-



foot wide trucks came between 12 a.m. and 5 a.m., and parked until the next day under the 118 freeway all the way up to the old



existing bridge that is a remnant of a dam dating back to the 1920's.

The girders are 138-feet long, each weighing 175,000 pounds. For those living in the adjacent Twin Lakes community who wanted to come and watch the crane at work, Foremost provided coffee and donuts.

Deerlake Ranch was originally introduced as a 535-home development back in 2001. A community coalition formed a non-profit in 2002 called **Save Chatsworth, Inc.** for the express purpose of monitoring the approval process of this development. **Save Chatsworth** successfully negotiated for a reduction of size in the project, as well as obtaining many valuable community enhancements such as public sewers for the

adjacent Twin Lakes community, extensive and improved equestrian trails and access, protected open space and other funded amenities. The reduced density benefits Chatsworth and its surrounding areas, cutting down on noise, dust, and traffic, and saving parkland.

**Save Chatsworth** continues today as an organization closely aligned with **SSMPA**. ~Vanessa Watters

### Living with Coyotes in Your Neighborhood

Many of us live in areas coyotes frequent, so how do we co-exist with coyotes?

Coyotes are naturally fearful of humans, but due to encroachment on their habitat, they have adapted to finding food in developed areas. Intentional or unintentional feeding can lead to habitation and conflicts.

What can you do to discourage coyotes (as well as rats and mice)?

- Pick up fallen fruit from trees
- Enclose all vegetable gardens
- Seal all trash cans securely
- Feed pets indoors or take pet food in immediately after feeding them outdoors and clean the area
- Do not leave water outside for pets

Remember, common sense goes a long way when dealing with Coyotes. Always be present when your pet is outside in your yard. When walking in the neighborhood, keep your pet on a short leash. If you encounter Coyotes while walking in the neighborhood, use hazing techniques like waving your arms and yelling "go away coyote" and/or use noisemakers to scare them away.

### Abused Land in Chatsworth

It's not a park. It's private property. But still, is there any excuse for this abuse of the land? And it's immediately adjacent to, and encroaching upon, a public park, Chatsworth Park North.

The City Department of Building and Safety charged the owner with the following violations in April 2016:

Grading was performed without first obtaining a permit.

Open storage of inoperable vehicles.

Rubbish, garbage, trash and debris on the premises.

Open storage within the required yards.

Orders to comply have been issued and our local Building and Safety inspector is monitoring. But it will be a long process to try to repair all the damage to the land.

Remediation work began in early April 2016 at Chatsworth Park South, at the far west end of Devonshire Street.
