## NEWSLETTER FOR MARCH 1972

Dear Friends:

Our Save the Stagecoach Trail Country Fair and Parade will have been over when you receive this, so be sure to come to this month's meeting when all the committees will be giving their reports on its results. Meetings are always held the third Monday of each month at the Glendale Federal Savings and Loan, 21881 Devonshire, in Chatsworth, at 8:00 P.M.....March 20th. Those of you living in Ventura County won't have to be making the trek over the hill each month to meetings; because, starting March 15th, SSMPA will also be holding meetings on the third Wednesday of each month in the upstairs meeting room of Bank of A. Levy, Los Angeles Ave., in Simi Valley at 8:00 P.M.

SSMPA is not dividing into separate units. It has, from the start, included as board members area chairmen from (1) Newhall and neighboring communities, (2) San Fernando Valley and (3) Ventura County. SSMPA began as a committee within Chatsworth Beautiful. Jan Hinkston was its chairman and soon her enthusiasm about preserving the beauty and environment of the Santa Susana Mountains attracted others from Simi, Newhall and as far north as North Hollywood. SSMPA was incorporated as a non-profit organization last year; and; as evidenced by the support given our recent hike-ins from numerous communities, we are an organization that encourages communities to work together for a healthier environment. We try to pool all of the many talents within SSMPA and use them in whatever area they are most needed. Now, if a Talent Coordinator or a professional in Public Relations would volunteer his services, then ALL our valuable human resources could be utilized in a far more efficient manner and SSMPA could really take off with wings!

SINCE OUR OPTION money has about reached the \$4,300 mark (plus \$1,000 from America the Beautiful) and option negotiations are eminent, SSMFA members may be pleased to learn that we have obtained a speaker for Monday's meeting whose topic will be APPRAISALS. A subject about which most of us have a great deal to learn.

NOW THAT THE COUNTRY FAIR AND PARADE are over, it means we can all pitch in and help our hard-working and long-suffering chairman of the "Save the Stagecoach Trail Sponsor Book," Joy Totschek, and all of those on her committee. This weekend--March 18th and 19th--has been designated as "Stagecoach Saturday and Sunday" for volunteers going door to door soliciting sponsor ads in their neighborhoods. This Sponsor Book is important, not only from a fund raising viewpoint, but it is one way to prove to government officials how strongly the people want and demand to have preserved some of our remaining open space and cultural heritage for our children and our children's children. Two unique and largely unspoiled mountain ranges--the Santa Susana Mountains and the Santa Monica Mountains--separated only by a few miles of hills need desparately to be protected from development. Both mountain ranges are the only reasonably close fresh air and open space refuge for the millions of people living and working in the smog choked city below.

The Santa Monicas are coastal mountains and, as such, provide for many the only form of water recreation. Development would mean the end of natural open beaches and rustic mountains.... in its place would come luxury hotels, commercial amusement areas, loss of ocean view and access limited to those who can afford the \$. The Santa Susana Mountains rise above the heavily populated San Fernando Valley and the rapidly growing Simi Valley. These mountains are rich in oak filled canyons; high, but accessible, peaks bathed in sun even when the valley below disappears beneath a sickly yellow blanket. Equestrian trails grow fewer and fewer....soon horses will be banished completely from these two valleys. The history of the Santa Susana Mountains is colorful and rich from the time of dinosaurs--when the towering mountains were uplifted from the floor of the sea; through the age of the ancient Indian tribes who dwelled throughout the Santa Susanas as evidenced by archeologists' findings; to the time of the Mexican and Spanish settlements and large ranchos; on down to when the pioneers made the long, hard migration west and stage coach trails, (such as the section of trail the SSMPA is seeking to purchase, were the freeways of that day. In an 80 square mile area where so many different periods of history are still evident--it would be an injustice to our descendants not to save this living history for them too. When all the Indians, Mexicans, Spanish and pioneers used it without spoiling it, why should we be the ones to allow its destruction?

There are many avenues by which our city, county, state and federal governments can assist in helping all of us to save the Santa Susanas; but, unless we can SHOW them that we--as INDIVIDUALS--care enough to do something, all the fine words in the world will fall on deaf ears. HOW do we show we care? This is how: (1) WRITE LETTERS or a POSTCARD in your own words to all of your government representatives--500 separate letters are worth 1,000 names on a petition and 100 hand-written post cards or letters will have more impact than 400 signed form letters.

Two suggested representatives to whom you can write are: Supervisor Warren Dorn and Councilman Robert M. Wilkinson. Their addresses are:

Ask Supervisor Dorn to use the money they were going to use for the County Knudson Parkway (scheduled to extend from the end of Devonshire west, '... through Chatsworth Park South, turns north across the Southern Pacific Tunnel, the Simi Freeway and through the remote areas of the Santa Susana Nountains to Piru). Instead, use the funds for a park and save taxpayers all that money by buying the Stagecoach Trail! The Parkway would desecrate Chatsworth Park South--the environmental impact would be indescent and the cost outrageous.

The cost of the Parkway just from the end of Devonshire to the Simi Freeway would surpass the land cost of the Stagecoach Trail all the way to the pass. Since the County has a four million (\$4,000,000) surplus, the parks should get their share. It could save the Stagecoach Trail--already declared an Historical Site (No. 92) by the City of Los Angeles.

A suggestion when writing to Councilman Wilkinson is that he try to initiate an ordinance to buy the land for our proposed park and/or coordinate with the County to buy land for a Regional Park.

After you've sent these cards, the way to prove you intend to use more than words is to help purchase the Stagecoach Trail by deciding what you do best and then choose your area of activity within SSMPA. The rest will come naturally. When we purchase theis trail, we'll have proof of public action as well as public interest.

Every activity in SSMPA has its "moment of glory" and right now anyone who's a good fund raiser is top banana. So, no matter what the rest of us are deeply involved in, let's try to give the fund raising committee an extra hand now when they really need it. The Sponsor Book has tremendous potential because its ads run from one-liner children's names for a dollar and one adult or Mr. & Mrs. for two dollars to commercial ads ranging in price from business card size for \$10 to a full page for \$100. The commemorative book will not be just ads. One fourth of it will be devoted to an editorial section including articles on the Stagecoach Trail and the surrounding Santa Susana Mountains, facts about the geology, archeology, plant and animal life and history of the area and of those who lived there, as well as colorful sidelights about bandits, treasures and hair-raising rides on the trail itself -- all illustrated with excellent photos. The book will have something for everyone so those taking out ads will get their money's worth. Joy reports that as of March 8th the total amount collected is over \$700; so, if only a few people managed to bring in this much in such a short time, think how much we can do with all of us pitching in. She has plenty of fact sheets explaining the project and will send one to anyone interested. Please note the change in the Social Service permit number -- it is now No. 1873.

DISNEYLAND HAS AGREED to provide a special trip to the top salesman in our teenage division--all schools take note. We are awaiting word from LAS VEGAS for confirmation of a free weekend to the adult who brings in the most money. Names should be printed exactly as they will appear in the publication and complete addresses should be supplied. Material for commercial ads should be supplied "camera ready." The proceeds from this sponsor book will go into the Santa Susana Mountain Park Land Trust Fund as have all previous SSMPA donations.

Jan Hinskton, our President, reports we have received formal notification from the I.R.S. indicating our Federal tax exemption status.
