39 ACRES ADDED TO THE PARK

The California Fublic Works Board on Jan. 28 approved the expenditure of \$995,150 for purchase of 39.81 acres for addition to the Santa Susana Mountains Park

The parcels include the former Spahn Ranch and part of the Kelly ranch. The Equestrian Center has retained 10 acres for its operations.

This is the second state purchase for the Park. Fure ther purchases are planned including the Stage Coach Trail.

Assemblyman Robert C. Cline rushed through legis lation last year to beat deadlines. He has worked since 1971 in the acquisition process.

LITTLE LEAGUE WINS, WILDLIFE LOSES

The City Council has overruled its Recreation, Library and Cultural Arts Committee and decided to allow the use of 14 acres of the Chatsworth Reservoir basin as a Little League baseball facility.

The proposal now goes to the Water and Power Commission and the Recreation and Parks Commission, which has previously opposed the proposal, for their consideration.

Letters to the Recreation and Parks Commission, City Hall East, 200 N. Spring St., Los Angeles, CA 90012 and to the Board of Water and Power Commission, Dept. of Water and Power, p.o. Dox 111, Los Angeles, CA 90051 would help. Both agencies have opposed the action previously.

A letter to Councilman Hal Bernson, 18917 Nordhoff St., Suite 18, Northridge. CA 91324 expressing your opposition would also help.

Councilman Hal Bernson supported the proposal which had been previously opposed by environmentalists and near-by residents who claimed the wildlife would be disturbed.

At the annual tour of the basinlast month, hundreds of geese and ducks were visible and many other species of birds have been reported.

Bernson denied claims that the basin is a natural wildlife preserve and added that the Little League season does not conincide with the time the geese are in the area so there would be no threat to the birds.

Chatsworth Lake is now almost dry because the dam has been declared unsafe for earthquakes. The Department of Water and Power says it will be at leasr five years before it can be rebuilt.

It is still too weak to be effective in saving many trees, according to Helen Treed of the Oak Tree Coalition. It has been even weakened rather than strengthened.
