#### SEWAGE AGREEMENT CONCERNS CITIZENS

A proposed sewage disposal agreement which would allow increased development in the north of the Simi Freeway and west of Topanga Blvd has drawn citizen concern.

The agreement would allow the area outside the city to be served

by City sewers.

The agreement between the Las Virgenes Municipal Water District and the City of Los Angeles draws questions about the impact on:

 the capacity of the City's system in the Valley,

the City's planned land uses in and around the area,

the cost of providing the services,

4. the potential for providing other City Services in the future and the possible request for annexation.

quest for annexation.

At a Public Works Committee meeting, Feb. 23, Councilman Marvin Braude expressed concern for two of these areas. He asked for a mechanism to control sewer connections in the County when the City sewage capacity is limited. He also asked for a review process to allow input from the City Planning Department. He indicated the desirability of being able to control sewer connections in the County for compatibility with City planning. A City Bureau of Engineering representative assured him that his conditions could be incorporated into the agreement.

In view of SSMPA and Mr. Braude's concerns we suggest that these conditions be included in any agreement negotiated with the Las Virgenes Mun-

icipal Water District:

 that the City establish a mechanism to control sewer connections in the County when the City"s sewage capacity is limited;

2. that the City require review by the City Planning Department of County Developments requesting sewer connections and require compliance by those developments with the City plan for land use and

provision of public services in an around those areas.

3 that the City be guaranteed that the cost for the new sewer connections and their operation and maintainance

#### MINNIE HILL PALMER, 94, DIES

Minnie Hill Palmer who was believed to be the longest term native resident of the Valley has died at 94 years.

She was born on her parents' homestead in Chatsworth on Nov. 30, 1886, six months after it was homesteaded. She was the seventh of eight children of James D. and Rhoda J. Hill.

The original 120-acres were expanded to 230 acres by her husband Alfred, and broth er Lovell. It was used as a stopover on the stage coach route through the Santa Susana Pass nerebye. It is the last remaining homestead in the Valley. It was dedicated last May as Los Angeles Historical Cultural Monument No, 133.

Mrs. Palmer sold the property to the City in 1956 to be used for Chatsworth Golf Course and Park. She was allowed to live

She continued to work her property and maintain her garden until she suffered a stroke five years ago and could no longer live alone. Her husband died in the 1940s. She spent her final years at Mountain View Sanitarium in Sylmar.

Until her illness she worked in her garden every day, starting at 7 a.m. She grew most of her own food and put up about 300 jars of jelly for Christmas gifts. She was famous for her quince pie and lemon jelly.

When the fires of 1970 threatened her home, she refused evacuation and helped fight the fire.

Fart of her garden was singed but the house was saved. It contains many pictures and books which are used in research. It is at the edge of Chatsworth Park South and is open for tours each month conducted by the Chatsworth Historical Society.

Mrs. Palmer died March 1 and is survived by her daughter, Edith Butler of San Fernando, a son, Leroy Palmer, a sister, Calla Nelson; two grandchildren and four greatgrandchildren.
