


1990 Year of the Oak

1990 Year of the Oak

Joan Sander organized the Sunday, March 31, 1990
Rally to Save Sunshine Forest by preventing a dump expansion project there. Sunshine Forest "is a closed canopy oak forest of 8,600 oak trees...It is a Significant Ecological Area, a wildlife habitat and a very special place"... "Many of the beautiful canyon areas in these Santa Susana Mountains are under attack from the Bureau of Sanitation and the County of Los Angeles who want to turn (potential) parkland into dumpland. What is the answer to the trash crisis? The answer is recycling ... We need to learn the 3R's of protecting the earth: Reduce waste, Recycle and Reuse!"
