#### PROPOSITION 117 WINS!



Joan Sander is working hard to save the unspoiled portion of Sunshine Canyon. It contains 542 wooded acres with approximately 5,600 Oaks, hundreds of Sycamores, Black Walnuts, and Big Cone Spruce. Joan was featured in the Daily News Section called FOCUS in the May 29th issue. Joan has been recently appointed to our Foundation board as Santa Clarita Area Chairperson.

#### JUNE 6th TOUR

Jan hosted a tour for Santa Susana Mountain Park Project Coordinator, Robert Baxter, of the State Dept. of Parks and Recreation. Don Hunt of Rancho Simi Parks District gemerously provided transportation. Parcels viewed included the Corriganville Park in Ventura County, and the Rocky Peak Park (Bob Hope's Runkle Ranch). Mr. Baxter was impressed, and realized that the State Parks Dept. needed to adjust their thinking to include the Bob Hope Deal in their studies of the Santa Clarita Woodlands area to then create a whole Santa Susana Mountain Park such as we proposed back in 1970.

He was also shown the archaeological sites which are endangered by development adjacent to the State parkland. He suggested that we try to get reclassified as a State Historic Park in order to better protect our archaeological and cultural resources. Anyone interested in volunteering to help with this specific goal, please contact Andre van Meulebrouck at 818 998-0498.

Also, please write to Senator Ed Davis to request new classification as a State Historic Park...so that we can get better protection of our resources, and start some major interpretive programs of transportation "Over the pass, into the Past". After that, with the fruition of the Bob Hope Deal, we finally have the opportunity of becoming a State Park from the Santa Clara River to the Santa Monica Mouintains as in our original proposal back in 1970.

## SABOTAGE AFOOT!

We have just learned that some legislators in Sacramento are trying to cut back funds from Proposition 70 (passed in 1988) and the newly passed Prop. 117 by somehow combining them and deleting some of the allocated funds! Could this action be in retaliation for so many initiatives passed on the ballot? Our grass roots effort to get Prop. 117 passed came directly from the people. We will not tolerate such a flagrant violation of our constitutional rights. Senator Ed Davis is working to prevent its passage in the Senate.

## WHAT YOU CAN DO!!!
