PAST HAPPENINGS

We wish to thank Walt Parker for his great program in September...it was very informative and humorous!

Nancy and Jan went to an Audubon outing on Oct. 5th in the Chatsworth Reservoir and saw a Golden Eagle and a Green Heron, and the first small group of Canada Geese flying in V formation overhead... "maybe a scouting party to see if the habitat was still here", we joked. The wintering birds are beginning to show up - get out your binocs!

The "Trek to China Flats" was a super multi-user event. Somewhere between 300-400 people either biked, hiked or equested to this South-Westernmost extension of the Simi Hills. However, the three of us who had started off from Vanowen into El Escorpion Canyon - West to Las Virgenes Canyon - North awhile - then west some more (all with special permission from Ahmanson). This hot, uphill climb into upper Cheeseboro, and then up to China Flats took longer then anticipated. It was only a 1500' gain in about nine miles, but two of us got heat exhaustion, and were rescued by two equestrians and one biker (Peter Heumann). While Linda Palmer and Charlotte Brody (E.T.I.- Corral 54) provided wet scarfs, and a Laurel Sumac, shade, we cooled off and rested enough to feel better while Peter rode to get a truck to take us the rest of the way - a tour of our destination - and then back to our van - Vanowen - and home - tired, but happy! Maybe we'll do it again in the spring when its cooler! Next time we'll start from Victory -it's simpler!

The BLM hearing was informative - we have until Nov. 15th to send our written comments - bring some stationery to the meeting so that we can do it together. Dorian and Jan are still doing some investigating for more of the facts.

A CORRECTION - Oh brother did I goof! Diane Huffman is a student at Pierce College - not CSUN. ENCLOSED is a petition for another try at saving the Ancient Forests up in Northern California. There is no money required - only regulations that will hopefully prevent anymore tragic giveaways of the very last of this precious resource. Our own survival is at stake. If you are a registered voter - just make sure that all signers are also registered voters in only one county. Fill out the card if you can help further. We only have about a month to get 650,000 signatures. The legislation that was passed has been amended (watered down) by the lumber interests - and the governor vetoed that. This is our only hope!

A new offer has been initiated by Joe Edmiston on behalf of the MOUNTAINS RECREATION AND CONSERVATION AUTHORITY to Bob Hope. Hope has been asked to sell all of his land, including the Jordan Ranch, Runkle Ranch, Corral Cyn. for \$29.5 million. The deal includes a donation of PIA's 350 acres leading south from Cheeseboro Cyn. to the 101 freeway as part of a new joint partnership (proposal?) with Ahmanson which includes a PGA Golf Course, 2600 units and a donation of 3,025 acres to the Conservancy. The total acres is 10,390. Mr. Hope, PLEASE SAY YES!

GOOD NEWS! AB 1152 was signed by Pete Wilson. Now the State Parks Dept. will have some say in regard to the extension of Reseda Blvd. Thanks to all you letter writers - you've made a difference! Our November program will have Jill Swift show us the "Big Wild"...now made a bigger possibility.

Also, the US Senate has removed the restriction about using condemnation for the National Park Service in regard to the Soka Property...now all we need is more money to match.

SSMPA and the FOUNDATION had a joint meeting in order to set priorities for acquisition for the new L.A. County Bond Act. More info at the next meeting.

On March 10, 1888 a subdivision map for the town of Chatsworth Park was filed with the Los Angeles County recorder, giving the area its first real name. Shortly thereafter the rail-road was completed to Chatsworth Park and this station built. The railroad gradually dropped "Park" from the community's name.
