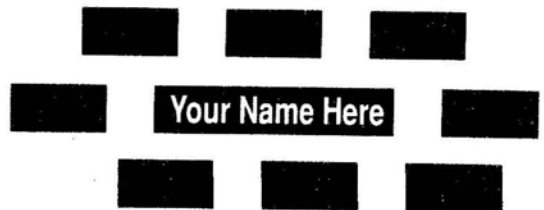

## **CONGRATULATIONS FOR A JOB WELL DONE!**

Despite a short deadline, limited government funds, and people on summer vacation, the SSMPA through its Foundation for the Preservation of the Santa Susana Mountains, was able to co-sponsor a grant application with the California Dept. of Parks and Recreation which resulted in a matching fund federal grant. The federal portion was \$3,312.68 while the State Parks granted \$687.68, and our Foundation put in \$2,500. The money will be used for one week's worth of trail repair and restoration by the Conservation Corps on our old Stagecoach Trail property on 10,000 feet and the reseeding the area with native vegetation by State Parks biologists.

Besides our Foundation board, who authorized the \$2,500 donation, special recognition goes to Lindsay Wilhelm who recently finished a grantsmanship course. She arranged a tour of the property with State Parks and our Foundation representatives to work out details, and kept in constant communication with State Parks grant writer Neil Braunstein and State biologist Suzanne Goode. Nancy Razanski notified State Parks and faxed them the grant application. Also Pauline and Nancy drove our Foundation's check to the State Park's Calabasas office to insure it was received on time. Janice Hinkston, who was away most of the time, was able to participate on the August 14th tour with State Parks along with Lindsay and Nancy and offer much expertise. Barbara Coffman, on vacation, contributed input for finalizing work details after the grant was obtained as soon as she returned home. Cindy Wilder and Janet Lazik offered resource information. Fantastic team work!

SSPMA was one of eight participants in the First Annual Chatsworth Historical Society's Chili-Cook-Off at its successful Pioneer Day Celebration on October 1, 1995.
