Stagecoach Trail Hikes

SSMPA hikes are conducted every Sunday, October - June (except fifth Sundays of the month & rain-outs are occasionally a problem) from the parking lot of Chatsworth Park South Recreation Building, which is located at the western terminus of Devonshire Street, about one mile west of Topanga Canyon Boulevard.

Hikers meet at 9:00 a.m. with the hike leader for the four mile (700 ft. gain) loop up the Stagecoach Trail, which is in the hills west of the park. Hikers are advised to bring water and a snack in hiker's back pack or hip pack. Lug sole shoes or sturdy, closed shoes are advised as is the wearing of a hat. All hike leaders are knowledgeable and experienced.

The Los Angeles Urban Resources Partnership Grant Program has informed the Foundation that they are one of several awardees for a grant applied for in June, 1997. \$1,400 will be awarded to the Foundation for a four week decent training program in early spring 1998, and for improvement of displays at the Foundation's Visitor Center at Chatsworth Park South. FROM THE ARCHIVES

This month's FROM THE ARCHIVES concerns information collected by the non-famous anthropologist John Peabody Harrington. Harrington, who lived in Simi Valley during the last part of his life, was probably the greatest collector of information about the Indians of the United States that ever lived. However, although Harrington collected an amazing amount of information, very little of it was published during his lifetime....and he remains largely unknown (except by experts) even today (what a shame!). What is of interest to us here is some of the information that JPH collected on a trip to the Chatsworth and west SFV area in 1917. JPH and his Fernandeno Indian consultant "Melendrez" (and an other native person) traveled from the City of San Fernando to the West Valley, as far as Bell Canyon. Their journey through this area may be the only one where a professional recorder took notes from a local Indian. This set of Harrington notes describes the geography of the west SFV and the old Indian and the early historic settlements of the area.

"Melendrez" was a child of the old mission system, He apparently knew very little of the old language and his English was not the best either, so much of what he describes is in Spanish. Melendrez tells Harrington, as they reach the west SFV, that there is a rock on a hillside called "la luna". The hill where the rock is located is also called "la luna", as are the entire group of hills where "la luna" is located. One of the few Indian names that Melendrez remembers is "Mwar" (i. e. the Moon), which refers to this rock. The higher hills to the north are called (I am translating here) the "hills of the Devil" (i. e. of the Indian's God). These comments appear to refer to the hills at the east side of Chatsworth Reservoir and to the Simi Hills themselves, respectively. The party passes by "Las Pilitas" (the pools - apparently this refers to the old De la Ossa homestead), and by "El Escorpion de las Salinas" (i. e. Chatsworth Reservoir). They arrive at the old Domec adobe (now the site of the Chatsworth Lake Manor Chapel) and stop and discuss the rock paintings of the area. Melendrez informs JPH that the area of Chatsworth Peak is a sacred place and that there used to be a large Indian village in the Chatsworth area. The group proceeds and passes "La Calera" (the old lime kiln seen at the NE end of Chatsworth reservoir) on their way to "EL Escorpion, Viejo" (Charlie Bell's ranch @ Bell Canyon). Here the natives discuss three caves which are (or were) inhabited by evil spirits (especially the terrible Munits).

They also discuss the painted caves @ Burro Flats, local mineral springs, the Santa Susana Pass area, other local places (e. g. Bannon's quarry), local families (e. g. the Mirandas), and they provide us with some stories relating to these places.

Harrington's notes for the area include a number of photographs and sketches, including some quickie maps of the area (I have not have a chance to review these other materials, yet).

Gopher Road to Rock Quarry

The road just north of Deerlake Highlands is listed in the new Thomas's Road guide as Gopher Road. A stream with a lush riparian corridor runs along the road for about a quarter of a mile. The western slope is severely eroded as a result of the road cut. The road leads to a rock quarry locally known simply as the Rock Quarry and was apparently quarried for road or foundation rocks. According to aerial photo maps, the operation was active before 1976 until the late 1980's. Heavy cement pieces of roads or foundations have been dumped there, some recently.

On the left, what appears to be a cement foundation is in fact an underground weighing platform for truckloads of rock. Above the weighing station a road winds up to the quarry.

Two horse trails lead out from either end of the quarry. There are probably other horse trails further up Gopher road along the stream. The horse trail at the west end of the quarry ascends a small messy canyon with sandstone walls bearing finely etched lines from tricking water during the rains. The trail then cuts into a bench meadow and heads toward an old ridgeline fireroad that eventually joins with the Rim of the Valley trail system.

The east trail leads to Deerlake highlands with a fork on the left to an overlook. Straight ahead the trail heads for Deerlake Highlands. A right fork runs along the north side of a foothill and connects with the old fireroad along the ridges.

The fire road to the right runs out along the ridges but to the left it goes to the old homestead noted as a "well" on the US topological maps. A chimney still stands there and nearby sits a small cinderblock pumphouse which looks like it may still be in

use. A road leads east about 200' to the house of the Deerlake Highland caretaker and his family according to the present owner/developer.

A few hundred feet to the west and unseen from here, the land descends steeply into the intricately eroded rock sides of Devil Canyon where rare Dudlea nestles in crevices of the damp canyon walls. The developer plans to build a clearspan bridge across Devil Creek to connect Deerlake Highlands with Twin Lakes. A clearspan bridge eliminates the expense and time of regulatory processes required by government agencies for disturbing wetland habitats.

From a spot south of the caretakers home, one can look out and see the ridge over blind canyon and in the early mornings a misty layer of fog arises in that direction indicating the canyon's deep lush interior.
