

# If Only The Lone Ranger Could Ride Again

Many western TV and movie films such as the revered Lone Ranger, Roy Rogers, Hopalong Cassidy, Gene Autry and several thousand other movies were filmed on location in the Simi Hills and Santa Susana Mountains. In the era of the 1950s the outlaws were shot from a distance without graphic violence and the "good guys" made every effort to capture, wound but not kill, the "bad guys." In a Lone Ranger radio program made into a TV film, 1949, the actor, Clayton Moore, playing the part of one of seven Texas Rangers, is ambushed in a canyon and stays alive by painfully crawling to a cool shady water spring running down a boulder. The actor, Jay Silverheels, in the role of Tonto, finds the Texas Ranger and nurses him back to health. Tonto buries six of the ambushed dead Texas Rangers and tells Clayton Moore that he is the Lone Ranger. A movie legend is born. Both the Lone Ranger and Tonto, the "Trusty Scout" made it their mission in future episodes to establish law and order in the region by capturing the bad guys.

It is over 50 years since the first filming of the Lone Ranger and so many great westerns. The population growth/ development in the area has altered the scenic views forever. Even more alarming are the illegal acts of land grading, dumping, and destruction of native plants, trees and rock formations that compromise this region's environment and wildlife. Because it's so difficult to stop the modern day outlaws, one dreams of hearing "Hi-Ho Silver, Away!" to know that the Lone Ranger and Tonto are back to stop the dark deeds by the "bad guys" throughout the Simi Hills and Santa Susana Mountains.

#### Chatsworth Trails Park Restoration Project

Save Chatsworth's grant funding for the Chatsworth Trails Park Restoration Project, Phase I, is enabling the restoration and revitalization of the 13-Acre Santa Monica Mountains Conservancy Park at Canoga and the 118 Freeway, commonly known as "Horner Park". The vision for this natural park area, which is widely used by equestrians and hikers, includes the removal of invasive, non-native plants, tree trimming and brush clearance, trash clean-up graffiti removal, the planting of new native plants and trees, and the establishment of a central rest area on the flat mesa, including benches, trash receptacles and hitching posts, and also informative and educational signage about the wildlife and birds that frequent the park. Much of this work has been completed by community members and groups, and there is more to be done. The project completion date is December 15, 2006.

# <u>Public Meeting #3 for Santa Susana Pass</u> <u>State Historic Park General Plan</u>

Weds., October 25, 2006 from 6:30 to 8:30 p.m. at Chatsworth Park South (Chatsworth Recreation Center/Gym), 22360 Devonshire St., Chatsworth.

California State Parks invites you to the third public meeting for the Santa Susana Pass State Park to present the single (preferred) plan and support material. The single plan was developed with the input received at the first and second public meetings held in January and June of 2006. After the presentation, the General Plan team will be available to receive public comments. Following this meeting, the General Plan team will prepare the preliminary General Plan Document. Upon the completion of this Document, the California Environmental Quality Act (CEQA) process will be initiated. After the CEQA process, the General Plan Document will be presented to the California Parks and Recreation Commission, which will entail a public hearing process.

The Board of Directors of SSMPA regrets to report that in spite of our strong support to put this historic adobe cabin and beautiful surroundings in the hands of the Rancho Simi Recreation and Park District, who had offered to purchase it for fair market value, the deal is off. Efforts to acquire the property were stopped by an aggressive private owner who is assembling property in the area, putting it out of reach of the park and its supporters. We continue to work and take steps to preserve other parcels and lands in the Santa Susana Mountains and Simi Hills and appreciate your support in this endeavor.

# Views of the Candidates (Please get out and vote on November 7th!)

The following questions were put to the two candidates for Ventura County Supervisor, Jim Dantona and Peter Foy, with a statement that their respective answers would be printed in this newsletter: "What is your position on the preservation and/or use of the remaining open space in the Simi Hills? There have been a variety of allegations of illegal grading, road building, dumping/land filling and creation of building sites in certain areas of the Simi Hills. What is your position with respect to these activities and what steps, if any, would you take to control them?" Here are their answers:



I enjoy the beauty of our hills and believe we should follow the rules of the hillside development ordinance that Simi Valley has adopted. It would be ideal if the open space were to remain pristine for all of us to enjoy. I believe this will continue because of the policies that are in place and the desire of the Simi Valley City Council.

I believe we have a responsibility and a legal obligation to obtain permits to perform work on parcels throughout the county. When these permits are obtained, we need to follow the guidelines that go with them. It is the responsibility of the Supervisor's office and the agencies that oversee these activities to ensure that work is done is accordance with the guidelines of the permit.

It is not too late! Before cement and asphalt replace hiking trails and wildlife corridors, remember I am the ONLY candidate for Supervisor who...


- Stood with local residents to protest illegal dumping.

#### PROPOSITIONS ON BALLOT FOR ELECTION NOVEMBER 7

Election day is coming up fast, and three of the 13 statewide initiatives on the November ballot could significantly help -- or harm -- California's health and environment. Now is the time to a) make sure you're currently registered to vote, and b) get involved in one or more of these important initiative campaigns. You may register to vote up to 15 days before election day (November 7). Absentee ballots will be available between October 9 and October 31. Proposition 84, Clean Water, Parks & Coastal Protection
Act would invest \$5.4 billion in California's natural infrastructure to
help ensure that Californians have access to safe drinking water,
are better protected from floods and continue to enjoy good
conditions at our parks, rivers, lakes, beaches, bays and coastline.

Proposition 87, Alternative Energy, Tax on California Oil would raise at least \$4 billion to promote clean fuels, clean-fuel vehicles and clean-fuel infrastructure and reduce California's annual oil needs by 4 billion gallons (about 25 percent of our current consumption). 
